- The expenditure on this account shall be booked strictly against those items which have been approved this office .
- Drawing & Disbursing officer shall satisfy themselves about the reasonability of cost , proper quality control , genuineness of work done claim and physical existence of works .
- The funds so released shall be utilized for the specified purpose after completing all the codal formalities / procedures as required under rules and shall not be available for re- appropriation / diversion ant any level .
- The Executing agency shall ensure that the work shall be taken up and completed within the approved cost only . No work shall be tendered / allotted beyond approved allocation . No cost escalation is allowed under the progammme .
- There shall be no overlapping of funds from any other sources such as SDRF/ District Plan/ Centrally sponsored schemes / Flagship progammme on any other available sources
- Utilization certificated of the said amount may be furnish bto this office along with full work done estimates so that balance funds are released accordingly .
