Sanction is hereby accorded to the release of funds amounting to **Rs 18.00 lakhs (Rupees eighteen lakhs only)** on account of preparation of District Irrigation Plans (District Maps Hard & Soft copy and others survey equipments) @ 1.50 lakcs Per District) under "**Pradhan Mantri Krishi Sinchayee Youjana**" (PMKSY) - one time grant for its utilization during the year 2016-17. The funds are placed at the disposal of following Drawing & Disbursing officers (DDO,S) as per break up given here as under :-

The release of funds are subject to following conditioned;-

- i. The funds shall be utilized for preparation of District Irrigation Plans (DIPs) under Pradhan Mantri Krishi Sinchayee Youjana " (PMKSY).
- ii. The maximum amount for preparation would be restricted Rs 10.00 lacs or the actual cost which ever less . balance amount if any would be refunded / adjusted in the grants to be released for preparation of DIPs for other Districts .
- iii. The preparation of District irrigation plans (DIPs) should be prepared with all concerned departments for Implementation of PMKSY .
- iv. To ensure that the request No. of DIps are prepared under overall supervision of Inter Departmental Working Group (IWDG) constituted as per the operation guidelines of PMKSY .
- v. The DIPs prepared shall be placed before the State Level sanctioning Committee for approval within the stipulated period .
- vi. The funds released is non recurring nature and while booking the expenditure the DDO should adhere the PMKSY guidelines issued by the Ministry in this behalf .
- vii. The DDO,s shall ensure that the accounts are maintained and are subject to normal progress of statutory audit like wise , and inventory of the assets created under the projects should be carefully persevered assets that are no required shall be transferred to the Nodal department for its use , and redeployment were ever possible .
- viii. The Services of IAS , IFS officers be utilized and their signatures recorded .
- ix. The DDO shall ensure that funds released are utilized prudently and judiciously and is no case they should book the expenditure just for sake of spending .
- x. The Expenditure shall be incurred only after observing all codal formalities required under rules .
- xi. The Department shall ensure that there is no overlapping / duplication in adoption of schemes / incurring of expenditure from nay other scheme of the State or Central Govt.
- xii. The Department shall furnish the progress report both in Physical and financial to the Directorate for its submission to Administrative Department .
- xiii. The DDO shall send utilization certificate by 31-03-2016 along with Physical and financial progress reports .
- xiv. The DDO shall implement the programme / work after accord of Administrative approval / technical sanction wherever required by the competent authority .
